This “Free Class” tuition waiver is available to first time credit students of all ages for fall or spring semesters with the following restrictions:

- ❖ Can be used in conjunction with ANY form of payment.
- ❖ Reside within South Suburban College District 510, or for high school students that attend an in district high school.
- ❖ Qualify for Lake County, IN or Chicago Regional rates.
- ❖ Work for an employer within South Suburban College District 510.

This Waiver

- ❖ May only be used one time, your first time and cannot be used with any other waiver.
- ❖ May not be used for summer term **unless you are a current high school student or recent spring** (same year) **high school graduate.**
 - *Those who cannot take advantage of this free class in summer may utilize it for the fall semester immediately following your first summer credit class.*
- ❖ Applies to one credit courses of 5 credit hours or less.
- ❖ **Applies to tuition only.**
- ❖ May require Placement Testing prior to registration except for PE.
- ❖ Must be verified in the Registration Department.
 - After verification is complete, student must take waiver to Financial Aid for processing before payment due date of the course. (Unless you are a high school student). High school students must take waiver to cashier for processing.
