Miscellaneous:

George Dammer, President, made a request of the Board Members and others present to contact their State Representatives to oppose passage of HB 1876. This legislation could establish a precedent to provide individual member subdistricts for all Illinois community colleges. Worse, the legislation requires that the Illinois General Assembly determine where the subdistricts shall be drawn and overrides the Board's local authority. The amendment is technically flawed in that it uses census track data which does not fit into community college districts well. Community college districts were originally based on high school or unit school district boundaries.

With no further business, the Chair called for a motion to adjourn. Katie Jackson Booker moved and Jacqueline Martin seconded. Voice vote carried the motion unanimously. The meeting adjourned at 8:25p.m.
