**Documentation Required:**

→ Attach a copy of your Member 4 DD214

**Documentation Required:**

→ If you claimed your dependents on your Federal Income taxes. A Copy of your 2016 IRS Federal Tax Transcript

→ If you did not claim your dependent(s) on your Federal Income Taxes. Please complete the following:

→ Provide a detailed statement and submit with this form. Explaining how you financially support your dependent(s) also include (i.e. paid day care receipts in your name, insurance cards, etc)

→ Attach a copy of legal dependent(s) birth Certificate

**Note:** The Financial Aid Office will review your information and determine if your documentation is sufficient to demonstrate support of your dependent(s). If determined that you do not provide more than half of the support for the dependent(s) listed, you will be considered a dependent student and will need to update your FAFSA to include your parents' information.

**Emancipated Minor:** As determined by a court in your state of legal residence, are you or were you an emancipated minor?

**Documentation Required:**

→ Attach an official copy of the court's decision corroborating your emancipated status.

**Legal Guardianship Verification:** As determined by a court in your state of legal residence, are you or were you in a legal guardianship

**Documentation Required:**

→ Attach a copy of your court decision documents appointing your legal guardianship **OR**

→ If guardianship has been terminated, attach a copy of the court order of discharge from legal guardianship

**Unaccompanied Homeless Youth:**
